Report of the Council President -

Karen welcomed those attending Mount Zion's 60th. AGM. and asked that they read the reports for 2017. She thanked everyone for venturing out in the unpredictable weather.

Some of the highlights she noted for 2018 will be the reno of the small kitchen; lighting replacement upstairs for which two grants have been received; a Seminary student starting in September whose time will be divided 2/3 Mount Zion and 1/3 to The House of Friendship and a new committee to be called The Evolution Committee whose mission will be to investigate Partnerships and Property development, for the future.

Report of the President Karen Gastmeier

Mount Zion was a happening place during 2018. New programs thrived, we saw a slight uptick in overall Sunday morning attendance and we welcomed 22 new members. The building was alive with activity almost every day. Surely the presence of the Lord was in this place.

Our new Café flourished, welcoming between 30 and 40 seniors for a time to socialize and have coffee followed by a tasty soup and bread luncheon. Late last year, they added a drumming circle session for those who wanted to participate. Head drummer is Anne Lowe. I hear plans are underway to add a few new things this year. This Ministry to the community is a project of the Health Committee aided by Nurse Christine. It got underway after a goal setting session in Jan. 2016 and it has expanded every year since. Just goes to show you that having goals works. Health Committee members, who are always looking for some new help, are, Betty Behm, Mary Slethaug, Stephanie von Shilling, Marg Tupling and Rita **Schaus** They can be found in the Glebe Room every other Wednesday with soup ladles in hand.

New last fall is an adult learning hour held once a month following a Sunday morning service. Members are invited to stay for lunch and discuss pressing questions of the day through a faith perspective. Fittingly, the program is called *Perspectives*. Between 20 and 30 folks attend. **Pastor Philip aided by Intern Leanne** organize the sessions. **Pastor Philip and Joy** often take on preparing the lunch.

Also organized by **Pastor Philip** is the Friday Night Family Supper, advertised as "all kinds of food for all kinds of families". Sometimes pizza is brought in, sometimes it is potluck. Whatever food is served, fun is on the menu.

In order to discuss council's work for 2018, I have to step back a few months to October of 2017, when council, using information gleaned

from the previous September's Open Council meeting, voted to strike a new working group charged with proactively exploring, researching, and planning for our future.

The Evolution Working Group, as it became known, of **Dennis Eaton**, **Stephanie Von** Schilling, Mary Thompson, Marnie Boyd and Bill Gastmeier started their work early this year. They presented their report to the Open Council meeting in September. And while their report had a dizzying amount observations and recommendations, just the talk of change energized the congregation. Change and transformation began long before the report was finished. Their report sits alongside our bylaws as a guiding document for council and staff's future planning. Along side of those and other regularly scheduled activities, there were celebrations, fundraisers and special services. Not knowing which to highlight first, I have listed them by date.

Sharing resources is an idea often talked about but rarely practiced in church circles. Inspired by that thought and our newly found "evolutionary" thinking, we decided to join with other Lutheran and Anglican congregations for Wednesday night Lenten Services. We hosted one of the services and honouring our tradition, we welcomed the visiting congregations to a soup supper prior to the service. It was well received, so much so, that soup will be a part of every rotating Lenten service this year. Thanks to Pastor Philip and Deacon Scott for arranging the details.

Following last year's annual meeting, council welcomed new members **Ginny Ehrlich and**

Betty Behm who joined Stephanie von
Schilling, David Murison, Pauline Finch, Alfred
Durichen and Karen Gastmeier as members of
council. Richard Brubacher continued in his
positions of Treasurer and Chair of Finance
Committee. Pastor Philip, Deacon Scott and
Intern Leanne are ex officio members.

In May we saw the end of an era as quilters, Gladys Roeder, Violet Rank, Ruth Huehn, Doris McCourt and Kathleen Windsor stitched their last quilt. They were the last active members of a group that started the same year as our congregation, first meeting in 1956 in Rev. Delton Glebe's basement. By stitching scores of quilt-tops on commission, they raised enough money to purchase major appliances such as the industrial dishwasher and to pay for or subsidize many building renewal projects. Thanks Ladies your years of support for the congregation are appreciated.

The Ecumenical Welcoming regrouped in order to catch up with the family of Shinga and Esperance with a shower in celebration of their newest member ...Baby Ben.

During the month of August, a few church council members donned painters' hats as they renovated the small office in order that our soon to arrive Intern would have a place to work. They also cleaned and decluttered an accumulation of "not needed anymore" items from the auditorium storage closet to make room for new tables. Both rooms are functioning better and look great. Thanks to Richard and Susan Brubacher, Stephanie von Schilling, Karen and Bill Gastmeier and his trailer.

After a quietish summer, fall happened. My personal calendar attests to the amount of activity that went on preparing for a number of special events and services.

Intern Leanne Darlington began her internship with us in early September. She is at Mount Zion Sunday, Tuesdays and Wednesdays until September 2019. She spends the balance of her

week with the House of Friendship. Having Leanne in our midst has proved to be a delight as we watch her grow into her role of pastor. Leanne is mentored and supervised by Pastor Philip and an internship committee made up of Anne Lowe, Martin Juergensen, Fern Greb and Karen Gastmeier.

Council held its fourth annual "Open Council" meeting, a time for all the leadership in the congregation to gather, share and socialize. Council's work is guided by the conversation and ideas that this special time generates. This year, as previously stated, we heard the Report of the Evolution Working Group.

On September 28 Mount Zion hosted the synod's Ordination Service where close to 200 people attended. Thanks to the working group of Brenda Wynowsky, Susan Brubacher, Stephanie von Schilling, and friends for offering an exceptional reception with their apple and Luther-themed decorating, apple tarts and cheesecake.

The addition of coffee following every service may not seem worthy of mention. However, our mission statement opens with "We are a welcoming congregation," so it seemed fitting to add it to our Sunday mornings. We have **Pastor Philip** to thank for putting together the pot when he arrives.

On October 21, council held a General Meeting in order to vote on offering Deacon Scott a "tenured" Call. The vote which was 59 in favour of 60 votes was an affirmation of his call here and his ministries with the wider church and community. We are grateful that Scott will continue his ministry at Mount Zion. Along with his considerable music talent, he is also brings great organizational skills and energy to the Mount Zion team. Thanks to the Mutual Ministry members, Mary Thompson, Lynne Swanson, Helga Juergensen and Richard Crossman for conducting surveys over the summer which led them to make their recommendation to council.

In November we were delighted to learn that Music for the Spirit received a grant for musical instruments from Music Counts TD Community Music Program. The \$18,000 grant was presented by JUNO Award winning artist Derek Miller on Six Nations of the Grand River Territory.

New this year was Mount on the Move, a fundraiser in support of Mount Zion's Choral Scholar Program. Delicious cooking scents and the sounds of music greeted the approximately 150 people who attended. The event raised \$4,666. Music on the Mount also received a \$5000 donation at this time. Organizers are being encouraged to do it again. Thanks to the planning group Susan and Richard Brubacher, Brenda Wynowsky, Stephanie von Schilling, Karen and Bill Gastmeier, Deacon Scott and Pastor Philip. Thanks to the many musicians who participated and those of you who volunteered to help serve food, work on the donation desks, set up tables and clean up. It wouldn't have happened without you.

An astonishing 22 new members were welcomed officially as members at December 9th's New Member Sunday. Some came to us by way of transfer; others had been attending a few years but only made the decision to join when the New Member Sunday was announced. Others were attracted by the leadership of Pastor Philip and the warm welcome they received. About half were members of the now disbanded Maranatha Multicultural Caribbean Lutheran congregation. These new members have brought their traditions with them to Mount Zion including their annual Christmas Party which attracted many members with its Caribbean cuisine and Steel Pan Band. The Canada Lutheran will feature a photo of the new members in its January edition.

I learn a lot in acting in my role of President of Mount Zion's council, I pick up a lot of new things about theology, worship planning, accounting, contracts, but best of all is the joy of working with a team of dedicated, talented people. This year I added a few more things to my list of learned things, those being that *Evolution is our ideal partner and Sitting on the sidelines is not an option*.

I want to say thank you to all of you who sat on committees, cooked for a special event, acted as a reader or usher for a service or one of the many tasks that make Mount Zion happen. Special thanks to those of you who have helped keep our building safe and maintained under the guidance of **Kirk Swanson.**

I particularly want to thank **Pastor Philip** for his gentle guidance, **Deacon Scott** for his encouragement and quiet prodding, **Stephanie Von Schilling** for her ability to get things done and **Richard Brubacher** for guidance, expertise and patience.

A very special thank you to **Rita Schaus** who after five years as council secretary will resign at the end of the term. It would be interesting to count the number of minutes she has recorded in the past five years. Council keeps her busy with at least two meetings a month, sometimes more. We thank you Rita and we will miss you.

Pastor's Annual Report

As the baptized community of faithful, we are a gathering of children, youth, women and men who hear, believe, and receive the living Christ in Word and Sacrament and are sent out into the world as witnesses of the good news of Jesus Christ. Our witness as a community flows from our identity that is shaped through Word and Sacrament, inviting us to live out our faith in the world. Faith is always active in love; love calls for justice in the face of injustice in relationships and in structures of society. It is in grateful response to God's grace in Jesus Christ that we ought to live out our call for the well-being of society and the wider creation. Here we do not live for ourselves but rather our calling is to be there for others wherever we are called to. We are to be a serving and liberating presence in the world.

Looking back at 2018 there has been many a reason to be grateful for grace that allowed us to be faithful to our call to be a welcoming, caring community, called by Christ and enabled by the spirit, to share God's love by living our faith. Looking back at the past year, one could discern the Spirit guiding us to continuously discern new and different ways; to share the gospel, to love our neighbor and to be the church.

There are many elements of our life together that impacted us profoundly this past year. The Evolution Committee, who was tasked by the council to look into the future and suggest possible directions in ministry that we could focus on as a congregation, influenced the work of most other committees. The very existence of this committee pushed the others also to look proactively into the future and this also impacted the directions they took. The report of the Evolution Committee at the Open Council meeting of September 25 gave us plenty of material to think about in terms of future possibilities. Thanks to Dennis Eaton, Bill

Gastmeier, Stephanie von Schilling, Mary Thompson, Marnie Boyd for their efforts in putting together the report. The data they collected, and the pointers are invaluable.

Another happening that changed the face of our congregation are the new members that have joined our family of faith. This year we had the joy of welcoming 22 new members on December 9, and since that there have been more who have indicated their desire to become members. This is reflective of the character of Mount Zion as a congregation where all are welcome and find a space for themselves, as also the ministries and worship here. Most of the new members are from the former Maranatha Lutheran Caribbean Congregation, which has since closed. This has opened to us opportunities for new relationships and collaborations. Our relationship with St James, at St. Jacobs, has grown stronger, as we come together in joint Caribbean celebrations during Christmas and in February, the Black History Month. The congregation is blessed with the gifts that they bring to the varied ministries here and enrich what we do as a community.

Integrating our new members into our community and worship life is very important, so that they too would have a deep sense of belonging and fulfillment as members here. The challenge is to figure out how we could create the space and systems for intentional relationship building, how could we be sensitive to the traditions and cultures that are part of our own mosaic now? I would encourage all of us to go out of our way to get to know each other and introduce and invite the new members to the various ministries and activities of the congregation.

Pastor's lunches, which we now call 'Perspectives', were held on the last Sundays of the month, after worship. From Fall we call them Perspectives as we also spend time in discussing issues that are relevant to us as

communities. Among other things, we talked about whether politics had any place in church, and another time discussed new lyrics that were written to the tune of the hymn, A Mighty Fortress, by Dr. Allen Jorgenson! We hope to develop this into more intentional and deeper explorations and discussions of theological and social issues that all of us can identify with. Holding regular adult learning opportunities would be an area of focus for me this coming year, drawing also on the expertise we have in the congregation and outside.

Family Night Suppers were usually held on the third Fridays of the month. This is a time for younger families and members, and older members to come and share a meal together and spend the evening getting to know one another and building relationships. It is also a time to interact with the children and listen to their wisdom!

The congregational meeting and the vote on Deacon Scott Knarr's call, on October 21, was an affirmation of his ministry here at Mount Zion and with the wider church and it also reflected the optimism in looking forward, in the light of the evolution committee reports and the possibilities for ministry.

We had Jonah Bruce continue his placement here during the Winter semester in early 2018 and from the beginning of September we have Leanne Darlington as our intern. Having started training for ministry as a second career, she brings wisdom from her life experiences to her ministry formation. Her internship is a split one and she is at Mount Zion on Sundays, Tuesdays and Wednesdays. On Thursdays and Fridays she is at House of Friendship.

Mount on the Move, the extravaganza of music and food on the evening of November 17, was a wonderful time for members and those from the larger neighbourhood to come together and build community. A lot of folk, musicians and cooks and other volunteers,

contributed in making the evening as enjoyable as it was. But I would like to make special mention of Karen Gastmeier, Susan Brubacher and Brenda Wynowsky for all the time they put in to organize the event.

While the Evolution Committee looked into the future in terms of ministries, there was another group, the Finance Committee, who were keeping tabs of our finances and there were concerns as we looked into the future. But things did not turn out as bad as it could have been, we ended the year much better than anticipated. But this is a continuing challenge, given our membership numbers and demography.

Our worship continues to profoundly inspire and many, both members and visitors, have expressed so through the year. I am grateful for the leadership of Deacon Scott in our music ministry. This year we have Intern Leanne also in our planning team. The choir, other musicians, and the various other teams – communion assistants, lectors, ushers, greeters, altar guild, and others – contributed to making our worship experience meaningful and blessed.

Last year we did the midweek Lenten services along with other Anglican and Lutheran congregations in Waterloo - All Saints Anglican Church, St. Columba's Anglican Church, Christ Lutheran Church and Mount Zion participated. The focus for the services was Indigenous Spirituality. This year Trillium Lutheran Church would also be joining the group. The services are held at the participating congregations.

During Reformation Sunday, October 28, Shelby Rampl and Isaac Jyrkama were confirmed during the service. We have Matias Jyrkama, Maddy van Moerkerke and Nyah Marshall going through the confirmation program now. As has been for the past four years, we meet at Mt Zion once a month and also at Luther for a day, once a month. This arrangement gives the youth an opportunity to

study together and establish relationships with a larger group than just the one or two in their own congregations and also to experience a variety of leadership models. Six of our youth attended confirmation camp from August 26 to 31.

The ministry of the year past has been very fulfilling. I have preached the word, administered the Holy Communion, and presided over the sacrament of baptism and at marriages and funerals. Providing pastoral care and visiting those that were shut-in and ill was a joy. Being allowed to journey with those that lost dear ones has been humbling. I have regularly reported to the Council and the Worship and Music Committee and attended the other committees of the congregation. I attended the Synod Assembly last June as a rostered leader from Mt Zion.

Mount Zion has been blessed with exceptional leadership and volunteers. Working with the various committees in their specific ministries this past year has been a delight and their work was a reflection of the passion and commitment of the members here. The various activities and projects reflected our concern for the needy and marginalized around us and shaped the core of our discipleship in living out our faith in community. Sunday school, youth activities, men's breakfast and other adult learning moments were organized. Oversight and management of finances were faithfully carried out. The property was kept well, staff were supported round the year. Besides there are many others who served as volunteers through the year.

A special word about our council! The commitment and concern of our Chairperson Karen Gastmeier, Vice-Chair Stephanie von Schilling Secretary Rita Schaus and all other members, for the wellbeing of the congregation and the ministries here has been inspiring.

As a congregation Mount Zion has not shied away in forming partnerships and

relationships with other entities. Some of the initiatives in forming relationships, for example with Emmanuel United Church in community support, or the network through Two Rivers Ministry Area, in providing pastoral or music leadership, could be pursued so we could share resources and support each other in ministry. Through Deacon Scott we continue our relationship with the Six Nations community. Adult learning is another area that we are blessed with resources and is an area to develop.

I continue to serve on the Candidacy Committee of the Eastern Synod and now also serve on the Racial Justice Working Group of the Synod. Besides these I am one of the Lutheran clergy on Interfaith Faith Grand River, an interfaith group which meets regularly to talk about and study issues from various faith perspectives and also to support each other in various ways. I also teach a course at Martin Luther University College, at the undergrad

I am grateful to the staff for their level of dedication and friendship this past year. The ministry team of Dn. Scott Knarr, Nurse Christine Ramseyer, Muriel Tillich and Intern Leanne Darlington is a pleasure to work with. The collegiality and support for one another is commendable and I remain thankful to them for making my task that much easier. I also thank the council and the various committees, especially the Mutual Ministry Committee, for all their support and encouragement during this past year. It has been a joy to be part of this faith community, it is hard to believe that it has been 5 years since I joined! I look forward to together discovering what God has in store for us. Let us do so in hope and trust, that the One who has been faithful thus far will continue to counsel, lead and accompany us as we journey on as a faith community. Faithfully,

The task of writing this annual report is an occasion to highlight where and when we have felt the presence of the Holy Spirit, and to take notice of the many ways she blows fresh breezes which encourage us on our journey of faith.

At Mount Zion we are all grateful for the witness and youthful energy of our choral scholars. These students from Wilfrid Laurier University's Faculty of Music have entered into our community life and brought joy and song to help us lift our praise to God. Thank you from the bottom of our hearts to Allison Bender, Claire Dingee, Louise Roulleau, Alysse Sailor and Zackary Evans-Whitley. You have been a gift to our congregation in 2018!

For several years we have been walking with the Six Nations of the Grand River community as the Music for the Spirit music program has grown and matured. January 28 several members of Mount Zion attended a special "Circle of Learning and Song" which was hosted by St. James, Elmira to raise funds for this music outreach program. Participants included the Inshallah Choir and Mino Ode Kwewak N'Gamowak drumming circle, which created a deeply enriching experience of sharing Indigenous spirituality through the Traditional Grandfather teachings and global song. It was encouraging to see other congregations in our ministry area support our friendship with Six Nations.

February 18 Pauline Finch and I performed several music selections at the Red Maples Seniors Chinese New Year celebration. As usual, the food was a real attraction!

It is a joy to see the Mount Zion Choir enlivening our worship through the seasons of the church year. **March 4** we joined forces at St. Matthews, Kitchener to present a special anthem in worship. Stepping outside the comfort of our usual routines is a learning experience and encourages us to see our own context with new eyes and ears.

Mount Zion hosted the midweek Lent gathering of Waterloo Lutheran and Anglican churches on **March 14.** As has been our recent custom, we began with a soup supper, followed by a brief Holden Evening Prayer and our speaker for the evening, the Rev. Rosalyn Elm, priest of Six Nations Anglican Parish shared the Haudenosaunee Creation Story and how it informs her faith.

Mount Zion once again welcomed the Full Brass musicians for our Easter Worship on **April 1.** It is a privilege to have this ongoing partnership with community players of such a high calibre.

On **April 11,** a group from the Two Rivers Ministry Area visited the Mosque on Erb Street. It was a unique opportunity to build understanding and open the way towards future dialogue. I found it interesting to hear the Imam say there was no music in their worship time because all of the prayers are sung.

On **May 5** a group of Lutherans and Anglicans, with Mount Zion members among them, visited the Woodland Cultural Centre, the Mohawk Chapel and St. Peter's Church in Ohsweken. Once again people discovered the resilience and depth of faith that is evident in our Six Nations neighbours.

St. Matthews Choir and their Director of Music Corinne Dutton came to Mount Zion on **May 6**. This visit gave Mount Zion choristers a lift and allowed our friends from St. Matthews to experience worship differently – in a positive way! **May 6** was busy day as we also hosted the Gloryland Chorus for an afternoon concert in support of Open Sesame. Thank you to Pauline Finch for your beyond-the-call-of-duty publicity and communications efforts to make this such a successful fundraiser.

Pastor Philip and myself have invested significant time in the planning and reflection for a special racial justice education and awareness building event which took place at our Eastern Synod Assembly on **June 22.** The impacts of that exercise were astonishing and we hope to be able to share some of this learning and journey with folks at Mount Zion in 2019.

Summertime always brings the opportunity of more relaxed and spacious time to meet and talk with congregation members. As parish musician, so often during the year I am running to and fro in preparation of the many aspects of my ministry. Sunday mornings just don't seem to be a good time to chat – until well after most people have left the building!

The choir embarked on a new journey and on **September 23** we became recording artists! That Tuesday was the first of many meetings that I have attended, and I have learned that meetings are of vital importance to the Mount Zion community. Mount Zion is an active congregation and it is essential to be in communication with one another! I attended monthly Worship meetings, Council and Council Executive meetings, Service Committee meetings, and staff meetings. I also met monthly with the Internship Committee which consists of Anne Lowe (Chair), Martin Juergensen, Fern Greb and Karen Gastmeier. Parish Nurse 2018 Christine Ramseyer RN

2018 has been another great year! I continue to feel so grateful for the opportunities to serve at Mount Zion Lutheran Church. This year has been another busy one with so many opportunities to connect with church members and visitors.

Of importance to note this year is the wonderful community that has been built through the Mount Zion Cafe. Twice per month (Sept – June) the health council members coordinate and run the cafe. It is a time of great socialization, a nutritious meal and so much more. When looking around the room at each cafe, I am impressed with the welcoming and friendly atmosphere present each time. The health council members are to credit for this as they set the tone with their wonderful hospitality to each guest. Those who are new are given special attention and company. It is my pleasure to be present at each cafe to check in and visit with those who attend. Blood pressure checks and general conversations allow me to check in on any health updates or condition changes and then follow through as needed with phone calls or visits. In a short period of time, I can touch base with many people. I also provide an educational handout each cafe. Prior to our lunchtime prayer, I take a few minutes to speak about the health related topic on the handout. For the most part, it is seniors who are attending the cafe which continues to serve the church council's mandate for more programming for seniors.

Home, hospice and hospital visits continue. Sometimes Mount Zion members prefer to connect through emails or phone calls instead of home visits. Occasionally I will meet with members at the church. I continue at times as appropriate to mail cards of encouragement during health challenges or after a loss. This year, subscriptions for dealing with loss after a loved one's passing were ordered for quite a few church members. There is opportunity to

follow up to provide grief support. There always seems to be a need with our current health care system to advocate for health needs of our members and seek out resources. This often occupies a fair amount of my time but is appreciated and a valued help to those members. It can be a very difficult and tiring journey when one's health starts to decline. It is not an easy time for people when this happens. I try to be supportive however I can be when this is happening to church members. There have been some who have been recipients of frozen soup during times of illness or recovery. It has been really nice to have a selection of nutritious frozen soups in the freezer that can be taken to members when I visit to help make a few meals easier for them. Health education continues to happen on an ongoing basis as opportunities and health conditions present themselves. Looking forward into 2019, there will be some more opportunities for health education at the church which is at this point in the early planning stages.

I am pleased to write articles for the Mountaineer and am always open to any suggestions for future topics. Staff meetings, Mutual Ministry meetings, Health Council meetings and monthly Kitchener-Waterloo Parish Nurse meetings continue on a regular basis. I am aware of the fortunate position I am in to be surrounded by such wonderful teams of people. From church committee members to the staff that I am able to work with, they help me in my work and make it a real pleasure to be around them.

There are many church members that I visit that like to have communion with each visit and I am happy bring it to them. For others, communion is mostly preferred before Easter and Christmas. Pastor Philip and I ensure that everyone has the opportunity for a visit and communion prior to these two Holy seasons.

I am intentional about being present at funerals to help in any way I can. I am also intentional

about attending some of the extra events that occur at Mount Zion. This allows me an opportunity to connect with those that may not come to the café and are not on my visiting list. It allows me to be visible to other church members. A highlight this year was having the opportunity to speak one Sunday morning in February during church. I spoke about the value of a spiritual connection with God when experiencing health concerns or a health crisis. Other special days like Soup'r Sunday and Christmas Eve services allow me the opportunity to connect with members.

I attend and support all the events sponsored by the Health Council. Some of these include educational events, book studies, occasionally a prayer station and more. I have had the opportunity this year to attend some events outside of Mount Zion. The two that immediately come to mind is the MAID discussion series in St. Jacobs and hearing about all the great work Emmanuel United Church is doing with their wayside program. There has been an increase of phone calls coming into the office of community people in need of emergency food hampers and vouchers. We have spent some time researching what is available in the community and have a plan to assist those who call in, in the future. I have also been a point of connection with the health unit and our kitchens. First with renovations to the small kitchen and later with the routine yearly inspection. This yearly inspection coincided with a cafe day and was an opportunity to review the rules and requirements of the health unit when serving food at events that welcome community members.

My focus continues to be on the seniors of the church. When I think of programming or education, I think of our seniors. I continue to consider things that could be changed or adjusted within the church facility, or on the property that would make attending as a senior easier and therefore make Mount Zion as senior

friendly as possible. I continue to participate on my own time in community seminars, education and events that I feel will enhance my role as a parish nurse. The work has started to take special choir music from Mount Zion out to some of our home bound members on hand held devices. The music is on a few devices at this point and in the next short while, should be in the hands of some of our home bound members to enjoy. It has been a pleasure serving you in 2018 and I look forward to more great things happening at Mount Zion in 2019.

Evolution Committee

Appointed in February 2018 this committee of five canvassed all the major congregations in Waterloo, interviewed present and past Mount Zion congregants, met with major organizations such as the City of Waterloo, K-W Hospital, Working Centre, and Glebe counselling; resourced information from Synod files, demographics from StatsCan and conducted a demographic study of Mount Zion.

The intent of the committee was to further explore possibilities for Mount Zion in carrying out our mission. This could mean extension of our social commitment to the community, partnering with other churches or organizations on Social Justice Issues or embarking on new initiatives. All of these possibilities were explored and presented in the report, leaving the final decision to Council, some of which are already being initiated.

On September 25th a compilation of this research and recommendations was presented to Church Council, Committee chairs and interested members. A summary can be found in the October issue of the Mountaineer and on our website under "filing cabinet"

Mutual Ministry/Staff Support

Committee Responsibilities:

The Mutual Ministry Committee is a committee of the Church Council and functions on behalf of the congregation. It reports to the Council, normally through the Council liaison person. This committee may discuss items of a confidential nature. It serves as a personal and confidential support group to the lay and rostered staff. The committee focuses on the relational and compensation aspects of the staff positions. *One committee functions as support for all staff (2014 Council approval).

Activities 2018:

Our primary ongoing activities are to serve as a support group for rostered employees (Pastor and Deacon) and lay employees (Parish Nurse and Administrative Office Secretary). This academic year Intern Leanne is also included. We met with each long-term staff member individually on a couple of occasions during the year. We held group meetings/luncheons with staff, Mutual Ministry Committee members and a Council Representative, as part of our continuing effort to encourage communications among staff, Council, committees and the congregation.

We also have an ongoing evaluation role: conducting staff evaluations, performance reviews, and meetings for goal setting. Discussions relating to roles, assignments and expectations are held as needed.

On the administrative side, we serve as a liaison with the Finance Committee/Treasurer to make salary recommendations and to approve expenses for certain staff budget lines. We review and update employment agreements. We have oversight of workplace safety and employee material/physical needs.

In line with our responsibility to identify the staffing needs of the congregation, we

continued with long-range planning related to administrative and office responsibilities.

In addition to usual activities, in 2018 we carried out the process for evaluation and renewal of call for Deacon Scott Knarr, whose initial call was to end December 31, 2018. In September we recommended to Council that an open call as Diaconal Minister of Music be extended to Deacon Scott.

Property Committee

As chair of the property committee, I extend a thank-you to the members of the committee. Without the assistance and direction of Art Schelter, Ross Schlegal, Martin Jurgenson and Bill Brown, the projects completed would not have been possible. A number of projects were undertaken throughout the year, including:

- Servery reconstruction new cabinets, countertops, paint
- Rooftop heating/cooling unit replaced for auditorium
- Removal of raised floor in choir area and retiling
- Child friendly handrails in Open Sesame staircase
- Roof repairs to areas of leakage
- Shed assembly for Open Sesame
- Assisted electrician with changing fluorescent fixtures throughout church to LED panels
- Numerous small repairs throughout the building

For the upcoming year a number of projects are being considered or are in need of completion, including:

- Replacing the roof support posts in the courtyard outside of the auditorium (due to deterioration as a result of their age)
- Replacing vent hood fire suppression system in large kitchen (mandated due to age of equipment)
- Repainting the nursery for use as a nursery/meeting room
- Caulking windows in the office

- Tree cutting and reconditioning landscaping

- Furnace replacement at 235 Dawson
- Repairs to the cement walls in the boardroom
- Parking lot repairs

As our church building continues to age, there are a number of significant repairs that are going to be necessary, some more urgent than others. The property committee will be researching the costs and the best solutions for replacement or repair of equipment and the building itself in order to begin budgeting for these projects. As a final note, thank-you to those members of the congregation who assisted, or took on a leadership role, in helping with the maintenance of our church. For hauling garbage to the dump, painting, refurbishing the office and more, your assistance was much appreciated. It requires many hands to maintain our church.

Responsibilities: Our responsibilities flow from Mount Zion Bylaw #4. They involve the coordination of worship, music, communion and chancel decoration. Your WMC works to inspire varied and inclusive worship which respects our Lutheran heritage while being open to new directions. We discuss activities, support our Pastor, Deacon and Intern, review Congregational feedback and provide input for the Worship Planning Team.

2018 Committee Highlights: The WMC has been involved in many activities this year, including:

- Involvement in the planning and execution of our successful Mount on the Move event which raised close to \$5,000 in support of the Music on the Mount fund and the Choral Scholar Program.
- Production of a Choir Hymn CD offered for sale in support of the Music on the Mount fund.
- Preparation of Audio Kits for use by the "Friendly Visitors" to bring the Choir Hymn CD to our seniors.
- Extending the use of our projection system to summer months.

Nurturing a welcoming, caring community of faith

- Installation of a Sanctuary video camera.
- Expanding video production to include announcements before the service and live projection of Baptisms and Children's Learning and involvement during service.
- Installation of announcement screens in the Narthex and upstairs Lobby.
- Expansion of our Choral Scholar Program to three, partially funded through the Music on the Mount
- Additional receivers for our assistive listening system in the Sanctuary for Hearing Accessibility
- Continued involvement of the Hand Bell and Guitar Choirs in Worship
- Support of our Worship Services through the sacristy volunteers, Communion Assistants and Lectors.
- Held a **Country Music Sunday** in the Sanctuary.
- Care of the Organ, Piano and Sanctuary lighting, audio and projection systems
- Teaming up with All Saints and St. Columba Anglican and Christ Lutheran to combine Lenten Services on a rotating basis.
- Supporting Scott in his role with Two Rivers
 Ministry Area in providing music outreach to
 Six Nations through Music for the Spirit.
- Further modifying the music area for improved accessibility and functionality
- Considering respectful means of using and off-site repurposing of surplus pews.
- The German Language Service was further reinvigorated this year with increased marketing through a local radio station and attendance of over 80, many from outside the Mount Zion Community.

The choir averages 15 – 20 singers and prepares music for major Festivals and many other Sunday services as well as some funerals and other special events. We provide musical support for the congregation through hymns and liturgy as well as occasional anthems. The choir also participates in events involving the larger community. This spring we and the St. Matthews choir combined forces at both our churches.

The committee encourages congregational instrumental contributions such as flautists, pianists, string players and percussionists. The "guitar" and "hand bell" choirs have provided musical contributions at several services this year. We also support the involvement of soloists and guest musicians to enhance our services.

Committee Responsibilities -

From Operating Bylaw #1, Article 2.3d: This congregation shall live by faith active in love. It shall motivate, equip and support its members to minister in daily life, to participate as members of a caring community, to serve as Christians in all the institutions and structures of the society of which they are a part, and individually and corporately to promote justice and reconciliation, meet human needs and alleviate suffering. In these efforts the congregation shall co-operate with the Synod and the ELCIC, other Christian churches and other groups in society. It shall make certain that all its functions strengthen the motivation and ability for service.

2018 Highlights:

We continue to be inspired to focus our efforts on various types of service-related ministries: close to home, our local community, and in the broader community. This led us to educate ourselves and become involved with an amazing group of service oriented organizations. Through cooperative efforts, community connections and engaged members, we touched many lives. We also began to discuss ways to work collaboratively with other Committees and groups within our church.

Close to Home:

Mt. Zion Café – shared details of our Adopt-A-Causes and charitable initiatives with Café participants.

Martin Luther Univ. College (MLUC) formerly WLU Seminary – Lending Library - Household items donated.

VBS – our church hosted and supported the MLUC sponsored vacation bible school.

Our Local Community:

Marillac Place: a shelter for at-risk young mothers - Adopt-A-Cause: fundraising, donation of fresh produce, toiletry items, baby items, and specific household items; members were encouraged to donate their time at 'Bingo' fundraisers, on site helping with a multitude of tasks and with computer skills.

Trinity Village – porters took residents to the Chapel and hymn sings; provided help to serve at Tea Time.

Food Vouchers – grocery cards available through the office and ministry team, for those in need in our community.

Mitten Tree – see separate report

Potato Blitz, House of Friendship – collected donations of funds.

Food Bank – funds donated and food items collected.

Habitat for Humanity – donated food and donations to buy food, for a lunch provided to the volunteers working on the building project.

The Broader Community:

Indigenous Ministries – donations for the Music for the Spirit summer camp and the After

School Music Program, developed with the Six Nations community. We have designated this as a *partnership* in recognition of the deep connections we have now developed.

CLWR – Adopt-A-Cause: fundraising, and education regarding the various programs run by this agency.

We Care Bags – CLWR initiative – members fill a bag with specific items, e.g. learning kits, sewing kits, personal care. Bags are distributed to communities in developing countries.

We at Open Sesame Headstart Preschool are grateful that for the past 49 years, with the support of members of Mount Zion, we have been helping families with special needs children in our community.

We are thankful for our enthusiastic and caring teachers - Cyndi Publuske and Samantha
Beesley. We are also thankful for Jana Kelly, our Program Co-ordinator who does an amazing job in working with the Open Sesame parents, with our Treasurer, The Region of Waterloo, plus the agencies who refer children to us. Thanks also to Virginia Slack for keeping our classroom clean.

A Big Thank You to Joan Brunger for the exacting work she does as our Treasurer. Joan also applies for the Grants we receive which requires an involved application process

followed by reporting on how the money we received was used.

We at Mount Zion are excited about the new members who have joined our church family. Therefore I will now explain more about Open Sesame for those who are reading their first annual report.

Open Sesame Headstart Preschool is a program for 2 1/2 to 4 year old special needs children. Our main objective is to improve the lives of these children, along with their families, through their language development and social skills.

This will help them start their school at the same level of competence as other children. Society has learned that children with special needs require extra help to succeed in school. Without this help they may become labelled as slow learners or trouble makers throughout their school years and often do not become contributing members of society as adults.

Open Sesame is the only Headstart Preschool in the KW area and is highly regarded by the Children Services of Waterloo Region. Our license is from the Ministry of Education. We are inspected every year and are licensed for an enrollment of 16 children.

We work in collaboration with many social service partners. Our referrals come from KidsAbility, Kids Link, Healthy Babies Healthy Children, and Family and Children Services. We also receive wage enhancement and operating funding subsidies from the Region of Waterloo. The KidsAbility workers come during the day to access the children's progress.

Special thanks to Anne Woolner, Pat Edwards and Ann Crossman for continuing to assist our teachers in the classroom. We are always in need of extra hep and if you are interested in volunteering or would like more information about Open Sesame, speak to Ann Crossman

(519-884-3077) or Carol Ziegler (519-886-6675) after worship or call them.

The year 2018 was a good one for Open Sesame. On Monday Feb. 26th, members of Mount Zion and their friends ate at Boston Pizza, King St. N. in Waterloo, and we received 10% of all receipts between 5 and 8 p.m. We raised \$265 that evening.

In February we received a \$2,000. Grant from the Savvas Chamberlain Family Foundation. We are very grateful for this Grant which we receive every year at this time.

A Grant of \$2,040. was received in April from the KW May Court Club. We purchased outdoor equipment and toys for our playground. Work on our Natural Playground is expected to begin in the Spring.

On Sunday May 6th the Gloryland Chorus, directed by Bob Loebsack, along with Pastor Sebastian Meadows-Helmer on violin, were joined by the Crescendo Choir, (the Waterloo Region District School Board's Special Education Choir) as they presented a concert for the benefit of Open Sesame. After expenses, we received \$1,600. We thank everyone involved, with special thanks to Pauline Finch for her great job of promotion, as over 200 people attended.

In July, we received \$9,600.00 from a One Time Affordability Grant from the Region of Waterloo. This money covered the cost of an AC unit, new blinds for our classroom, plus the purchase of special toys and chairs for our children on the Autism Spectrum. It also reduced the cost of our program to our parents by \$1.00 a day.

Once again we thank the Mission Committee of the Eastern Synod of the ELCIC for supporting the work we do at Open Sesame with a Grant of \$7,000.

In early December, we received a One Time Technology Grant from the Region of

Waterloo. We bought a Chrome Book which will be used by our teachers.

We are also grateful for the memorial donations Open Sesame received from the funerals of Werner Packull and Melanie Joyner.

A Big Thank You to the property committee for installing low child friendly handrails above the stairs leading up and down from the Open Sesame classroom.

The Kiwanis Club of Waterloo North generously covered the cost of the gifts Santa (Jim Millar) gave out to our children on Dec. 19th. Jana Kelly and Carol Ziegler will thank this group in person when they speak to them about Open Sesame at their breakfast meeting on Feb. 26th, here at Mount Zion.

A Big Thank You to Carl Thompson for Open Sesame's ongoing fund raiser - selling grocery cards. Grocery cards can be purchased any Sunday from Ann Crossman by giving her cash or a cheque made out to Open Sesame. We sell Zehrs (Value Mart, No Frills), Sobeys (Freshco) and Food Basic cards in denominations of \$50. and \$100. Open Sesame received 5% of all grocery cards sold and this year we received \$2,342.50. We want to thank all those participating and hopefully more members will consider helping us in this manner. Your groceries do not cost more, you are simply paying for them in advance.

In closing we wish to thank all of you who faithfully support Open Sesame financially. Therefore the following letter we received last May from an Open Sesame parent is really addressed to you:

"My daughter started attending Open Sesame Headstart Preschool a year and a half ago. We were referred by KidsAbility, since she was receiving therapy there. When our daughter started she was barely able to communicate verbally. She had no interest in playing with other kids and had a hard time with routine. We look at where she is now and

we give tremendous credit to the teachers at Open Sesame for helping her develop necessary skills and communication. Having teachers who are so familiar with children on the Autism Spectrum was fantastic. They were able to connect with her and work on a level that she understood, while also challenging her when she needed it. There is a great balance of physical activity and more focused playtime. She has developed a love for the teachers and they are so quick to return that love back. She is now one of the friendliest kids you'll every meet and has hundreds of words in her vocabulary. Open Sesame has been such an incredible experience for her and such a great support for myself as well. It is great to have someone on staff who is dedicated to ensuring that the families are supported as well, not just the child. I can't say enough about how great a school Open Sesame has been for our family."

Committee terms of Reference - MZLC Bylaw #1, Article 2:3, Section e (Support) states:

"This congregation, in faithfulness to God, shall provide leadership, organizational structures, facilities and funds, to enable fulfillment of its' mission, and shall strive to maintain effective stewardship practices, regularly evaluate the total life and ministry of the congregation, and support members of the congregation to provide these activities".

Accountability: This committee is a committee of the Church Council and shall function on behalf of the congregation. It shall receive guidance and direction from the Council and shall make recommendations and suggestions to council. It shall report to the Council at all regular Council meetings, normally through the Council liaison person.

Responsibilities:

- 1. Oversee the financial affairs of the congregation to ensure prompt payment of all obligations and the forwarding of Benevolence monies to the Synod & others as designated.
- 2. Exercise responsibility for the congregations banking procedures, insurance programs and tax matters, and oversight of all funds and investments of the congregation and making recommendations to the Council regarding all congregational assets and liabilities.
- 3. Coordinating and working with all committees and the Council in preparation and presentation of annual budgets for approval at the annual congregational meeting.
- 4. Develop and recommend to the council, appropriate policy for Rental of Facilities & Parking and establish rates and contracts for Tenants.
- 5. Ensure that reports are submitted to Revenue Canada in order to maintain our congregational status as a charitable institution.

2018 Committee Highlights:

- Reviewed and discussed financial results monthly with recommendations as appropriate for council.
- Prepared and reported to Council and committee chairpersons monthly financial results compared with budgets, and prior periods with commentary.

- Provided monthly summary financial updates for inclusion in the Mountaineer & bulletin boards.
- Prepared budget recommendations as directed by the congregational council.
- Reviewed contracts and rental agreements and revised with recommendations for adjustments as deemed appropriate.
- Secured new facility rental agreement with Girls Rock! Camp for 4-12 yr. old girls in summer with major positive financial impacts.
- Provided policy proposals for the Memorial fund.
- Enabled a "Donate Now" facility on our web page through Canada Helps for online donations.
- Provided additional financial oversight to Open Sesame preschool.

I wish to thank our Bookkeeper Tim Ehrlich for managing the day to day financial activities, and our Financial Secretary Jackie Nunns in keeping track of donations. They are supported by Muriel Tillich and the counting teams, and the rest of the Finance Committee – Bob McDermott, Rita Schaus and Pastor.

Mount Zion Evangelical Lutheran Church 2018 Financial Review & Proposed 2019 Budget

The financial reports for Mount Zion are displayed in the following pages, and reflect actual activities for the year 2018, and the 2019 budget being proposed for approval at the AGM February 10, 2019.

The report is presented in several sections representing the accounting for Receipts and Disbursements within the various categories as follows:

Ministry & Mission (Current) - In support of ongoing ministry & programs

Benevolence - In support of the broader church & community outreach
Capital - In support of our facilities with upgrades & repairs

Rental Properties - In support of our rental properties

Special Funds - Restricted Funds - Designated for specific purposes
Balance Sheet & Summary - Summary & Statement of Financial Position at year end

2018 Overview

The year 2018 was a year of optimism as we saw our congregation accept into membership 22 new members. We also saw an expansion of programming and outreach with an expanding Mount Zion Café, and increased presence in our choral scholar program. Our facilities were abuzz with activity, not only from our programs, but expanded use with others renting our space. And as we closed the books on the year, this renewed energy translated into a positive financial picture with a deficit that was significantly below what was anticipated.

When we met at our AGM in February 2018, we approved a budget that anticipated a deficit of \$21,711 in our Ministry & Mission account. When combined with a small carryover deficit from prior periods, we faced the potential of \$24,000 needing to be funded from other sources by year end. Those sources were identified as either, increased membership, additional new revenues from rentals, use of Contingency funds, or our Mission Endowment fund. The congregation approved this plan on faith that we could manage this if we worked together and with God's guiding hand, we would continue to be relevant in our ministry in this community.

I am pleased to report that final results indicate an improved position with a small operating deficit of \$2,380 realized in 2018 resulting in a much smaller carryforward deficit of \$4,346. This amount has been funded with a transfer of funds from our Contingency fund enabling a clean slate to begin the New Year. Some highlights follow:

- We ended in a small deficit position of \$2,380 in Ministry & Mission (Current) \$19,331 better than the \$21,711 deficit expected. Thanks be to God!
- The improvement was due to higher receipts primarily from members, as well as increases in rental income from facility & parking. Consistent with our policy 15% of rental revenue enabled \$8,850 to be transferred to our capital fund.
- Benevolence support totaled \$70,512 in support of 18 organizations as well as the broader church as represented by our Synod. In addition, \$42,959 was received from the Synod and disbursed in support of the Six-Nations-Two Rivers Ministry Partnership to which Deacon Scott is involved. Since Mt. Zion administers these funds on behalf of Two Rivers Ministry area, the financial impact is included in our records for CRA reporting.
- Capital expenditures were more expansive this year with \$32,153 spent in upgrades to lighting, HVAC replacement, small kitchen refurbishment, and other minor refurbishment and additions. Capital fund balances at year end were \$37,860.
- Rental Property accounts were normalized in 2018 with positive returns resulting in a positive
 cash position of \$14,163 at year end. The extensive \$40,000 refurbishment of 237 Dawson in
 2015 has been recovered and expected further positive results will enable funding for a needed
 refurbishment of 235 Dawson in future.
- Activity in Special Funds designated for specific purposes increased by \$5,692. Major changes to these accounts were attributed to these factors:
 - Memorial funds increased significantly due to a generous bequest of \$15,000 in memory of long time member Shirley Hillier.
 - Music on the Mount fund increased significantly following the successful fundraiser in support of our choral scholar program, raising almost \$10,000.
 - Our Mission Endowment fund decreased by \$11,500 with the distribution of \$8,579 in earnings from 2017 and an investment loss booked for 2018.
 - The Contingency Fund provided by an anonymous donor in 2017 decreased by \$4,346 to fund our accumulated deficit in the Ministry & Mission account.
- Special funds designated for specific purposes totaled \$178,961 at year end, consisting of Mission Endowment Fund \$110,643; Contingency Fund \$25,654; Memorial Funds \$25,660; Youth Funds \$4,440; Music on the Mount Fund\$12,311; and Spiritual Retreat Fund \$252.

Thank you for your continued financial support in 2018. In so many ways, I believe we can say of 2018 results... Thanks be to God!

2019 Budget Proposal

The 2019 budget proposal included in the accompanying statements reflects an operating **deficit of \$37,160 for Ministry & Mission (Current) account.** This is a significant change from 2018 and reflects \$17,176 in lower receipts and \$17,604 in increased expenses.

Budgeted spending for <u>Ministry & Mission (Current)</u> is \$309,372 which is \$17,604 and 6.0% higher than the 2018 actual spending. Key assumptions follow:

- <u>Staff & Ministry Support \$196,812</u> Increase of 7.1% and \$13,128. No increases in staff positions, however an increase of 6 hrs/month for Parish Nurse. Economic increases of 2% and Synod guidelines for ordained/consecrated staff are included.
- <u>Committee Expenses \$25,225</u> Increase of 22% and \$4,592. Increased expense includes economic increases and expansion of the Mt. Zion Café and music program with choral scholars.
- <u>Church Operating Costs \$87,335</u> Net change of \$116. Increased utilities costs have been offset by reductions in Property management and custodial costs.

Budgeted income for Ministry & Mission (Current) is \$289,816 which is \$17,176 less than 2018. Member receipts show a reduction of \$10,000 acknowledging that 2018 included a few extraordinary donations not likely to be repeated. Endowment fund earnings of \$8,579 received in 2018 (earned 2017) will not be repeated in 2019 as no earnings are available from 2018. Increased Rental income is planned which will partially offset some other reductions. Our Plan reflects a continuing policy of reserving 15% \$(9,832) of Rental income to Capital reserves.

Our proposed budget for <u>Benevolence</u> as designated on our envelopes is \$28,000. This is in support of Synod \$24,000; Open Sesame \$3,000; Community Benevolence of \$500 as directed by our Service committee; and a Pastoral Discretionary fund of \$500. Special Benevolence areas including our Adopt A Causes are not typically budgeted as members contribute as deemed appropriate when various causes are identified.

The <u>Capital</u> budget assumes that income of \$11,180 and transfers from Rental Income of \$9,832 will be utilized to fund several capital expenditures totaling \$24,000 in 2019. Major projects include exterior building repairs \$10,000; Range hood \$3,000 Kitchen; Auditorium upgrades audio/visual \$6,000; and \$5,000 contingency. Total Capital funds were \$37,860 at year end.

The proposal for Rental Property is expected to be normalized in 2019 with income exceeding expenditures by \$18,380. This would result in \$32,543 in funds available for future upgrades and refurbishment of the properties.

The proposed plan acknowledges that the deficit in the Ministry and Mission account may reach \$37,160 by year end 2019. To fund this amount, the plan utilizes the available remainder of contingency funds of \$25,654, leaving an unfunded debt of \$11,506. A motion will be presented at the AGM on February 10, requesting congregational approval to open access to the Mission Endowment fund not to exceed \$25,000 per year beginning in 2019 to fund planned ministry and capital projects in the event that member financial support is insufficient to cover.

As background for this request, the following information is presented to help in understanding what resources are available, and the potential requirement for funding as we move forward over the next few years.

The following are available sources of funds now and projected at December 31, 2019.

This account reflects the costs and income associated with the support of ongoing ministry and programs. This category includes the permanent staff and committee expenses as well as the general costs associated with the operations of the church.


The results for 2018 reflect a final year deficit of \$2,380 compared to a budgeted deficit of \$21,711. This \$19,331 improvement was due to higher than planned receipts accounting for \$21,513, partially offset by higher expenses accounting for \$2,182. Member receipts accounted for the major improvement, along with higher rental income from facility and parking. In addition, Endowment fund interest earned in 2017 but paid in 2018 along with Other income was higher enabling this positive position compared to budget

The deficit of \$2,380 when combined with our carryover deficit from the prior years totalled \$4,346. This amount has been transferred to the Ministry & Mission account from our Contingency Fund which will enable entry into 2019 with a clean slate.

The graph below reflects the pattern of expenditure and receipts experienced on a monthly basis in 2018. The pattern of expenditures is relatively evenly distributed at an average of approx. \$24,100 per month, however the pattern of income is more eratically distributed with 31% realized in the 4th quarter. This results in many months where expenses exceed receipts. Continued emphasis on PAR (Pre-authorized Receipts) would help to level the income, and members are encouraged to consider this.



Statement of Receipts and Disbursements - BENEVOLENCE

Benevolence consists of two sections, - Regular Benevolence (envelope designated), and Special Benevolence - Designated Appeals. Both totalled \$113,471 in 2017 compared with \$127,329 in the prior year.

The regular Benevolence portion is budgeted and is in support of the Synod, Open Sesame, and a small portion allocated to community benevolence as directed by the Service Committee. In 2018 receipts were \$27,378, with a distribution of funds being \$26,878 to Synod, and \$500 to community benevolence. Compared to the prior year, regular benevolence declined by 6%.

Designated appeals realized receipts of \$86,093 which enabled disbursements to be made to 18 organizations. Included in this category are receipts from members of \$24,442 and \$61,651 in grants from others in support of various ministries. Grants include \$9,000 in support of Open Sesame preschool, \$42,959 from Synod in support of Six Nations-Two Rivers Ministry Partnership, and \$9,692 in support of our Intern supporting both Mount Zion and House of Friendship. All funds are disbursed to the organizations noted.

Statement of Receipts and Disbursements - CAPITAL & RENTAL PROPERTY

Capital reflects the costs associated with major expenditures for facility upgrades and repairs and the acquisition of new equipment or expansion of facilities. Costs in this category are incurred on an irregular basis.

Total receipts in 2018 were \$12,917 with disbursements of \$32,153 for a use of \$19,237 in capital funds. In addition, a transfer of \$8,850 from Ministry & Mission fund was made to reserve 15% of all rental revenue realized, in recognition that additional costs will be required to maintain the facilities. This resulted in a net decrease of \$10,387 in capital funds with a year end balance of \$37,860.

Expenditures in 2018 include: 1.) Lighting replacements \$9,681; 2.) HVAC replacements \$11,775; 3.) Hearing assists \$2,215; 4.) Office computer & equip. \$2,137; 5.) Servery Kitchen \$5,354; 6.) Portable AC Glebe Room \$519; 7.) TV monitors \$472.

Rental Property has been accounted for separately beginning in 2014. This was previously included in the Ministry & Mission(Current) section. This change provides more transparency into the total implications of our Rental properties including the ongoing upgrading that will be required to maintain the property values.

Results for 2018 reflect a surplus of \$19,298 which is \$17,973 better than plan. Our plan assumed that a new tenant would be required due to continued delinquency, and that upgrading costs would be required at 235 Dawson before a new tenant was secured. This did not occur, so both income and expenditures were positive when compared with plan.

Our bank position for Rental property is now in a positive position with a balance of \$14,163 at year end.

Statement of Receipts and Disbursements - SPECIAL FUNDS

The Special Funds reflect activity and balances of funds that have been designated for specific purposes as noted below.

The value of these funds is \$178,961 at year end reflecting an increase of \$5,692 compared with the prior year. Major chang were due to increases in Music on the Mount following a successful fundraiser in support of the Coral Scholar program which raised almost \$10,000. In Memorial funds, the major increase was due to a very generous \$15,000 donation in memory of long time member Shirley Hillier combined with other Memorial fund donations in memory of others who had passed.

Decreases were realized in the Endowment fund with the distribution of investment gains of \$8,579 from 2017, and the adjustment of \$2,921 due to expected investment losses realized in 2018. The balance in Contingency funds also decreased by \$4,346 which was used to cover the accumulated deficit in our Ministry & Mission account.



The significant improvement in results in 2018 was due to both higher than expected student fees, and the unanticipated receipt of government funding combined with successful fund raising. These increases however also required an increase in staff costs to manage the requirements for accountability and monitoring services for reporting to the Region. The 2019 plan reflects the full year impact of increased staffing, and some carryover spending to meet requirements of some of the grants and funds received in 2018.
